2. Previous Meeting

3. Captain's Report

a) New Members

d) Turn-Up Times

As stated in para 3c of the minutes of the previous meeting in March 2022, the motion to formalise the practice and increase tee times for the lady's turn-ups on Mondays and Thursdays to four tee times on both days was defeated by a very small margin at the Club AGM in March 2022. Anne has had discussions with the Club Captain regarding this matter.

Lady members are also encouraged to participate in the turn-ups organized by the Seniors (over 50 yrs) which take place on Mondays, Wednesdays, & Fridays. The Seniors section are keen to welcome lady members to these turn-ups.
